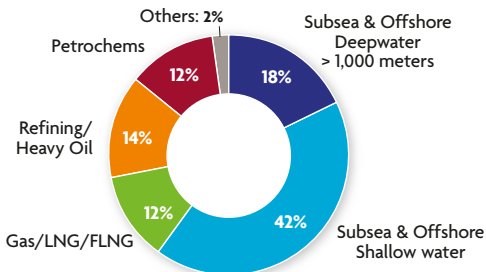

## Diversified backlog\*

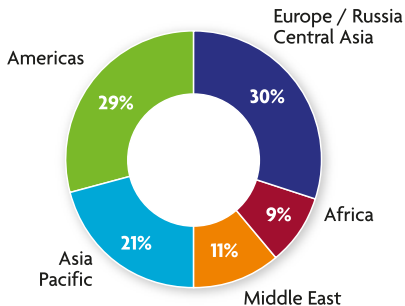
for profitable growth

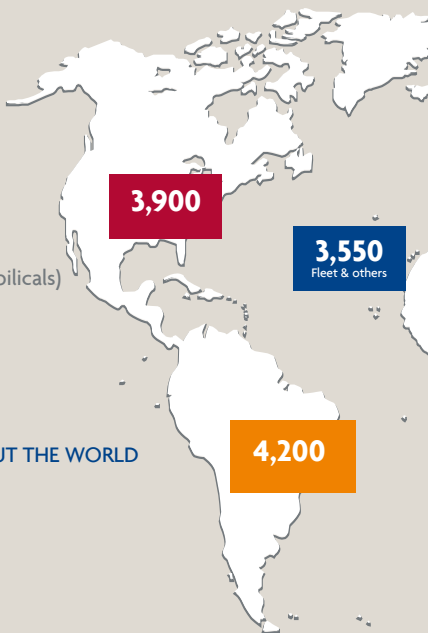

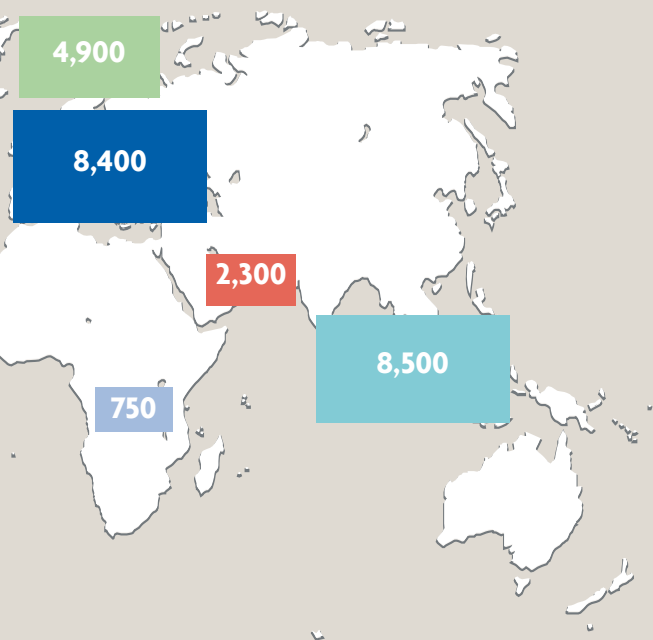
