• Accounts for over 20% of the world's consumption of corn, with the nation's demand for corn increasing 7% annually


• Currently theres is no nationally recognized grain brands -- at the same time, Chinese consumers are becoming increasingly health and nutrition conscious

• In particular, packaged and unpackaged grain food markets are rapidly developing

• The Chinese Nutrition Society recommends adults to consume 250-400 grams per day of processed grain foods, 50-100 grams per day of coarse and whole grain foods, and 30-50 grams per day of bean or bean-based products

• The potential market size of China's grain market is estimated to be over \$100 billion
