# **Building High Grade Silver Resources; Positioning Keno Hill Silver District for Restart of Operations**

Alexco owns 100% of the historic Keno Hill Silver District, located in Canada's Yukon Territory. The Bellekeno silver mine, one of the world's highestgrade silver mines with a production grade of up to 1,000 grams per tonne, commenced commercial production at the beginning of calendar year 2011 and was Canada's only operating primary silver mine from 2011 to 2013, producing a total of 5.2 million ounces of silver during that time. Alexco announced an interim suspension of operations at Bellekeno in order to decrease future All In Sustaining Costs and reposition the District for long-term, sustainable operations. Alexco is developing a plan to return to operation incorporating production from Bellekeno, Flame & Moth and Lucky Queen.
